
**Trempealeau County Humane Society
Foster Guardianship Agreement**

The undersigned Foster Guardian agrees to comply with the following terms and conditions of foster care for the animal identified above.

The undersigned Foster Guardian acknowledges and agrees that this document is a contract that provides for the terms of a foster guardianship of an animal that is property of the Trempealeau County Humane Society. This agreement confers no ownership or adoption rights upon the undersigned Foster Guardian.

The undersigned agrees that the fostered animal shall be provided at all times with humane care and maintenance, including proper food, shelter, exercise and veterinary care as necessary to maintain the health and well-being of this animal. The undersigned agrees to follow any and all directives of the Trempealeau County Humane Society specific to the particular animal identified above, including administration of any special diet or medications. In order to ensure that this care and maintenance are being provided, any agent or designee of the Trempealeau County Humane Society shall be allowed to inspect the fostered animal and/or the undersigned Foster Guardian's home at any time upon reasonable notice.

The undersigned agrees that the Trempealeau County Humane Society has the right to terminate this foster guardianship agreement at any time without notice. The Trempealeau County Humane Society reserves the right to refuse permission to care for any animal, to any potential foster guardian, regardless of circumstances, including past foster guardianships of a Trempealeau County Humane Society animal.

The undersigned agrees that this animal shall not be sold or given away to any other person or entity.

The undersigned agrees to notify the Trempealeau County Humane Society immediately if the fostered animal is lost, stolen, or injured, or if the address and/or telephone number of the undersigned foster guardian changes.

The undersigned agrees that this animal shall be fostered as a household pet that is housed primarily indoors.

The undersigned agrees to make the fostered animal available at the shelter during all open hours of the shelter, and any other time or place designated by an authorized agent of the Trempealeau County Humane Society.

The undersigned agrees that the fostered animal shall never be transported, caged or otherwise, in the open bed of a pickup truck.

The undersigned agrees that failure to comply with any terms of this contract as set forth herein constitutes a breach of this contract. Upon said breach and demand by the

Trempealeau County Humane Society the fostered animal shall be immediately returned to the Trempealeau County Humane Society.

If the Trempealeau County Humane Society must hire an attorney to enforce the terms of this contract, the Foster Guardian agrees to pay all attorney fees and costs incurred by the Trempealeau County Humane Society in enforcing this agreement.

The undersigned hereby acknowledges and releases on its own behalf and on behalf of all members of the undersigned's household, the Trempealeau County Humane Society, its board members, agents, employees, and volunteers from any and all claims, demands, actions, causes of action or any other liability for personal injury or property damage caused to the undersigned or others, by the fostered animal, and agree to indemnify and hold the Trempealeau County Humane Society, its board members, agents, employees, and volunteers, harmless from any such claims.

This agreement is binding upon the heirs, executors, administrators, successors and assigns of each of the undersigned parties.

The undersigned acknowledges, understands and agrees that:

- Household pets differ from humans in their response to human action
- The actions of pets are often unpredictable
- Pets around children must be supervised
- A pet's behavior may change after it leaves the shelter and becomes acclimated to its new surroundings

Trempealeau County Humane Society makes no claims or representations as to the temperament, health or mental disposition of any animal placed for foster guardianship.
